Do you enjoy teaching adult learners from multiple backgrounds, and making a difference in their lives? We are seeking ESL Instructors to teach adult English language learners enrolled in Festa's 3-Generation Family ESL program in Northland (Columbus, OH). The Adult ESL Instructor will plan lessons based on the learning needs of culturally diverse students and maintain a classroom environment that is conducive to learning. The Adult ESL Instructor will support students regarding instruction and monitor and record student attendance and academic progress. This position requires the ability to make routine decisions regarding the everyday operation of the classes, meet routinely with a supervisor, and work collaboratively and collegially with program staff and volunteers. Classes will be held Tuesday and Thursday evenings from 6:00-8:30pm, January-June 2026. This is a part-time, seasonal position.
